Doctors Mykel Taylor and Art Barnaby will make the presentation. Registration in some locations will start at 8:00 am with presentations beginning at 8:30 am and finish at noon, while in other locations, registration will begin at 1:00 pm, with presentations starting at 1:30 and ending at 5:00 pm.

The topics that will be included are an introduction and outline of the commodity programs and the major changes to crop insurance. FSA personnel will make a short presentation on commodity program procedures. We will cover the economic tradeoffs between the program options. Finally we will cover the OSU-KSU Excel based decision

aid tool. This will help participants to understand and utilize the tool in the evaluation of their farm numbers. We will also provide an overview of the decision aid tools that were funded by USDA that also cover the commodity program decision.

These meeting are being sponsored by 4 Premier Sponsors that include:

Supporting sponsors will be given non-preferred booth space, a public thank you from us during the meeting, and the opportunity to visit with their customers or potential customers during the breaks. The supporting sponsors will also be listed on handout material. The cost for being a supporting sponsor is \$500 per meeting or \$4,000 for all 15 meetings. The Premier Sponsors will have their logos on our slides and will receive the preferred booth location, but the cost was more than double.

We have at least two supporting sponsors who have already signed on through "word of mouth". We are now announcing publicly that any agribusiness who would like to be a supporting sponsor at one or more of these meetings, Kansas State University would greatly appreciate your support. Premier and supporting sponsors will receive a supply of \$25 tickets to pass out to consumers. County agents will also be given a supply of tickets. It is required that all participants have a ticket so that we can make sure we have enough coffee, handouts, chairs, etc.

USDA has stated that farmers will have at least until March 31 to elect one of the commodity programs. Once a commodity program is elected, that farm serial number is locked in for the next 5 years, even if the land changes ownerships or tenants. So this is an important decision that farmers will likely want to take their time evaluating their options. We don't expect most farmers will make a decision until after the first of the year, so these meetings should be timely. The Wichita meeting is accessible by air too; either private or commercial. Note the first meeting in Wichita is also the date for the National Collegiate Football title game. So you may want to select another location because I expect the Cats will still be playing football!
